

# Swine & Sheep Identification Procedure

**Step 1:** Tag the pig or lamb – disinfecting the tagger in-between each use.

**Step 2:** Take a one digital photo showing the ear tag. (shown as below)



**Step 3:** Take one digital photo showing the whole pig or lamb. (shown as below)



**Step 4:** Clean and disinfect the tagger.

**Step 5:** Fill out the Animal Identification Form. (Example on the next page)

**Step 6:** Send the digital photos and Animal Identification Form to [amherstmarketanimal@gmail.com](mailto:amherstmarketanimal@gmail.com) by April 13, 2023.

**Step 7:** A Confirmation Email will be sent back the same day. If you don't receive the Confirmation Email, we didn't receive your email. Please resend or call.
